We are writing in follow up to the first letter we sent you about fire safety works on your timber frame home. Thank you to all residents who have contacted us in response. We have updated the FAQs to address the questions we have received from homeowners, which are enclosed with this letter. We will update these FAQs on a regular basis to ensure we are answering the questions that homeowners have about the fire safety programme we have started.

We have received lots of questions about when the surveys on freeholders' homes will take place; these are anticipated to start in May 2024. As previously advised, once we know the results of these surveys, we will be able to provide more details about the exact work that may be required to your property. This does not mean you are agreeing to have any works completed; the purpose of the survey is to assess whether your property has any Category 1 hazards following an assessment under the Housing Health Safety Rating System and, if so then what remediation works, if any, are required.

We plan to hold drop-in sessions once the results of the surveys are known but understand many of you may wish to discuss your concerns with us before this, which we can do on a 1-2-1 basis. This can be in person or via email or telephone. Please do contact us by phone or email to arrange this.
